The Augusta Art Guild would like to invite you to be a part of our 25th Annual “Art in the Garden” that will take place on **Saturday, June 6, 2026 from 10:00 am till 5:00 pm**. This premier event brings together fine regional artists along the banks of the Ohio River in beautiful Augusta, Kentucky. In addition to showcasing exceptional art and artists, we provide live music and a variety of local food and wine.

Guidelines

- Vendors will have a 10' x 10' or food truck size space allotted to them during Art in the Garden. However, if you require more space, you can rent adjoining booth space for an additional fee.
- ***All applications must be submitted with your nonrefundable booth fee by April 1st*** (Nonprofit organizations are exempted from a booth fee). Any incomplete applications will not be considered. Please note that if you miss the April 1st deadline, you may still apply to Art in the Garden. However, you will automatically be placed on a Waitlist. Notification of acceptance will occur by May 1st.
- Art in the Garden takes place, rain or shine, on the first Saturday in June. There is no rain date.
- Vendors/Entertainers are responsible for all aspects of their booth set-up, including tent, tables, chairs, etc.
- Janet Hunt of Augusta Tourism's department has agreed to be the lead contact for all food vendors. Please contact her at jhunt@augustaky.com with any additional questions you may have.

We hope you will consider participating in this year's annual ART IN THE GARDEN.
